The *Members' Sales Gallery* opportunities are available for current RAL members only. The Rehoboth Art League (RAL) makes every effort to display Members' works to an ever widening audience. This is being accomplished by the year-round display of works throughout various venues, including our Henlopen Acres galleries (Corkran, Tubbs, Ventures, Step Up & Homestead); in off-site venues, such as the Rehoboth Beach City Hall, and in special public and private exhibitions. Every attempt is made to display as many Member's works in our possession as possible. Works of art are displayed subject to space availability.

Artists have the opportunity to link and/or update their personal contact or website information with a representative image of their work to the 'Artist Roster' on our website. **It is the responsibility of the Artist to complete and send the required information. Instructions on how to add and/or edit your information to the roster, can be found on our website. Visit www.rehobothartleague.org and click the "Artist Roster" link located in the footer of each web page.**

REQUIREMENTS FOR SALE

- 1) All artwork must be created within two years of delivery (i.e., no earlier than **2017**) and have never been displayed in any RAL gallery in the past. **This excludes off-site RAL exhibitions.**
- 2) All works must have a label securely attached to its backside (hanging works), underside (craft works), or a small tag (jewelry) that includes the Artist name and its title, production year, medium, and retail price. **The Artist's name must be the full first and last name of the Artist (i.e. initials and/or a company names will not be accepted. Note: Jewelry works and cards may require two small tags to ensure this information is complete and legible. Note: All labels must be completed and attached to each work by the Artist. RAL will supply blank labels upon request.** If desired, attach your Bio/CV to the back of each work.
- 3) Unless otherwise agreed to with the Artistic Director, all hanging works must be wall-hung ready with a wire. **Artists are responsible for rewiring works that have exposed wires when hanging, or are felt to be unsafe or unsightly.**

At the discretion of the Artistic Director, the RAL maintains the right to refuse any artwork that does not meet certain criteria (such as poor quality of framing, wiring, and matting), in addition to subject matter that may be considered offensive. RAL makes every effort to protect your artwork and is not responsible for any losses or damage that may occur. The RAL is not responsible for any wrapping materials or boxes used to transport works.

NUMBER AND SIZE LIMITATIONS OF WORK

- 1) **Wall Hung Works:** Artists may have up to two(2) wall hung works at any given time in the gallery. Artists may have either two smaller works up to approx. 20" x 24" (image size) each, or One smaller work and a larger work, no larger than 36" x 48" (image size). *In addition, an artist may also have up to two (2) matted works that are either professionally shrink-wrapped or placed in a professional clear sleeve in the gallery at any one time.*
- 2) **Jewelry:** Artists may up to 5 (five) works in the gallery at any given time.
- 3) **Stationery Works and Books:** Artists may have up to 4 books (per title) and **4 note cards (i.e, total of single cards and sets)** in the gallery at any given time.
- 4) **3-D Artists (Potters, Sculptors):** May have up to 4 pieces in the gallery at any given time. Larger works are subject to space limitation and may only be displayed with the permission of the Artistic Director.

TIME PARAMETERS- DISPLAY AND REMOVAL OF WORKS

Works may remain at the RAL for up to four months, and every effort is made to display Members' works. Although works may remain at the RAL for up to four months they cannot be on continuous display for the entire time. With over 700 member artists and shifting space restrictions it is simply impossible to have any work(s) on display for the entire four months. It is recommended that Artists who are able, to change out their works every two months.

It is not the responsibility of the RAL to call and remind artists that their work is past due for pickup. Works remaining in the gallery over four months are subject to a five-dollars/day/piece storage fee. Works remaining for a longer time are subject to being forfeited to the RAL. Monies received from the sale of these works will support exhibition programming.

PAYMENTS

Artists receive a sixty-five percent (65%) commission of the sales price of each work sold. The gallery agrees to pay all credit card fees. Payments are processed and mailed by the end of the second week of the month following a sale.
